

## Last Resort Supply Payment claim statement

Obligation to prepare and publish statement in accordance with paragraphs 9-10 of standard condition 38 (Treatment of payment claims for last-resort supply) of the Electricity Distribution Licence

### 1. Revenue recovered from the consequential increase in Use of System charges

In accordance with paragraph 2 of SLC38 of the Electricity Distribution Licence Use of System charges were increased in the Relevant Regulatory Year to such an extent the licensee reasonably estimates is appropriate to ensure that the consequential increase in its Use of System revenue will equal the Specified Amount in Co-operative Energy Limited's Last Resort Supply Payment claim. On 6 February 2018 Ofgem provided the necessary derogations<sup>1</sup> to allow DNOs to recover Co-operative Energy Limited's claim, via a supplementary increase of 0.08 pence per day to the domestic unrestricted, domestic two rate and LV network domestic tariffs.

### 2. Last Resort Supply Payments made in response to a Valid Claim to the Claimant

In accordance with paragraph 3 of SLC38 of the Electricity Distribution Licence during or as soon as practicable after the end of the Relevant Regulatory Year, the licensee must pay the Claimant in instalments as specified in the Valid Claim the amount of the consequential increase in its Use of System revenue, to the extent that it does not exceed the Specified Amount.

In accordance with paragraph A.3 of SLC38 of the Electricity Distribution Licence, if the amount recovered through Use of System Charges on completion of the processes outlined in paragraphs SLC38A.1(b) or SLC38A.2 of this condition does not equal the Specified Amount, the licensee must include the shortfall or excess in SLRA<sub>t</sub>, as defined in Licence Condition CRC 2B, Calculation of Allowed Pass-Through Items.
