INTRODUCTION

Welcome to our Sustainable Supplier Code. This is the first output from the ongoing collaborative working between ourselves and our supply chain, collaborations which are designed to help us all achieve our sustainability ambitions.

As we enter the RIIO-ED2 price control, and work to integrate climate action into all of our operations, we understand that strong engagement with our suppliers is crucial for the achievement of our sustainability ambitions - we cannot do it alone. We are taking a leadership approach to collaborate with our supply chain to facilitate full understanding of our sustainability values and ambitions, as well as engagement with all suppliers to further develop their own sustainability values to support, and where appropriate drive ours. During engagement sessions for our RIIO-ED2 business plan, supply chain stakeholders told us that they share the ambition to achieve net zero and they want to collaborate to tackle our Scope 3 emissions, whilst also reducing their Scope 1 and 2 emissions, but may need help along the way.

We recently launched a Supply Chain Sustainability School to help our supply chain understand all areas of sustainability and to assist suppliers on their net zero journey. Following on from this, we are launching this Sustainable Supplier Code which aims to forge stronger supplier relationships, enhance innovation and improve the management of shared risks and opportunities. It will also deliver greater value and outcomes for the environment, society, and local economies. Our supplier code is linked to five key UN Sustainable Development Goals (SDGs) that are most material to our business in terms of sustainable procurement, and are underpinned by the ISO 20400:2017 Sustainable Procurement Standard.

Our supply chain is instrumental in meeting our RIIO-ED2 net zero ambitions and our Sustainable Supplier Code, through its eleven targeted metrics, will ensure suppliers are helping us on our net zero journey whilst also gaining knowledge and improving sustainability through their own business.

SSEN's aim is to have 80% of its supply chain (by value) signed up to our sustainability code by the end of RIIO-ED2 in 2028.

This Sustainable Supplier Code is our first iteration heading into the RIIO-ED2 price control. We will be carrying out annual updates and a mid-point review (2025), with yearly targets adjusted based on supply chain maturity and targeted supply chain engagement.
