Owners of Generation or Demand assets greater than 50kW may be able to provide Flexibility Services.

- All interested providers need to pre-qualify and register their assets on our updated Dynamic Purchasing System (DPS)
- Upcoming tenders will be advertised on the Flexible Power Map and SSEN Website




PROCUREMENT PROCESS

- Prospective providers must register and pre-qualify on the Dynamic Procurement System (DPS) in order to participate in tenders
- There is a separate DPS for our North (SHEPD) or South (SEPD) network areas. Note that providers with assets in both North and South will need to register interest and complete questionnaires for both areas

SSEN use the Delta eSourcing Dynamic Purchasing System (DPS) for procuring Flexibility Services. Interested suppliers must register on the DPS and complete the pre-qualification questionnaire. If this stage is passed successfully, the supplier is added to the Select List and will be invited to any tenders that are relevant to the assets and areas in which they operate.

The DPS is open for supplier registrations at any time. Simply choose the region you wish to qualify for to view the full notice, then click on "Register Interest".



- Step 4: Once you have registered and logged into Delta you will see the screen below. You will find the opportunities to respond to under 'Response Manager'




