GUIDE TO NOVATION OF CONNECTION OFFERS/AGREEMENTS

This guide explains how to request a Novation of a Southern Electric Power Distribution plc (SEPD) Connection Offer/Agreement.

If your agreement is with Scottish Hydro Electric Power Distribution plc (SHEPD), please refer to the SHEPD Novation of Connection Offer/Agreement.

IN THIS GUIDE:

- The current party to the agreement = [Connecting Customer or Customer A](#)
- The new party the agreement is being transferred to = [Proposed Connecting Customer or Customer B](#)

WHAT IS NOVATION?

Novation transfers both the rights and obligations of a contract from one party to a third party. This could be due to, for example, the sale of a solar farm project where the original developer transfers the Connection Offer/Agreement to the new owner.

IMPORTANT

A Novation is not legally binding until signed by all 3 parties (us, the Connecting Customer and the Proposed Connecting Customer).

A Novation is not the same as an Assignment in Security, which is used when rights are granted to a funder as loan security. For Security Assignments, please contact: commercial.contracts@sse.com

HOW TO REQUEST A NOVATION?

1. Fill in the Novation template with details for both the Connecting Customer and Proposed Connecting Customer:
 - Name/Company Name
 - Address/Business Address
 - Contact Details (phone number, email)
 - Company Number (if applicable)
 - Project Reference Number
2. Send a signed copy (signed by both the Connecting Customer, the Proposed Connecting Customer and a witness) to:

WHAT HAPPENS NEXT

Once we receive the completed form, we'll review it, countersign and send a copy to both the Connecting Customer and the Proposed Connecting Customer, provided we've been given their contact details. If contact details are not supplied, the Connecting Customer must forward a copy to the Proposed Connecting Customer.

At this stage, the Novation is complete.

IMPORTANT

Sometimes we can't immediately approve a Novation Agreement, or approval may be delayed until certain issues are resolved. Examples include:

- Other agreements that must also be Novated
- Security arrangements that must be addressed
- Outstanding issues with the connection
- Outstanding balances due

If any of these apply, please contact our Quote Acceptance Team at quote.acceptance@sse.com before completing the Novation template.

ADDITIONAL GUIDANCE:

Business name changes – A Novation is not needed if only the company name is changing. It's needed only if the company number is changing.

Outstanding balances – Once a Novation is complete, the new party (Customer B) will assume responsibility for all outstanding balances, even if the payer remains the same. If any changes to the payment plan are required, please contact quote.acceptance@sse.com.

Offer/Agreement Variations – Completing a Novation applies to all variations of the offer/agreement, not just the current version.

Special Purpose Vehicles (SPVs) – If it is to do with a SPV please speak to our Connection Contracts Managers at commercial.contracts@sse.com.

1. Acceptance of liability

1.1 Customer A novates and transfers all its rights and obligations under the Connection Offer/Agreement (as varied from time to time) for

to Customer B.

Customer B shall enjoy all the rights and benefits of Customer A under the Connection Offer/Agreement, (as varied from time to time) and all references to Customer A in the Connection Offer/Agreement (as varied from time to time) shall be read and construed as references to Customer B.

~~1.~~ Customer B accept the liabilities of Customer A under the Connection Offer/Agreement (as varied from time to time) arising before, on or after the date hereof and agrees to perform all the duties and to discharge all the obligations of Customer A under the Connection Offer/Agreement (as varied from time to time) arising before, on or after the date hereof and to be bound by all the terms and conditions of the Connection Offer/Agreement (as varied from time to time) in every way as if Customer B were named in the Connection Offer/Agreement (as varied from time to time) ab initio in place of Customer A.

2. Acceptance of liability by SEPD

SEPD agrees with effect from the date hereof to perform all the duties and to discharge all the obligations of it under the Connection Offer/Agreement (as varied from time to time) and to be bound by all the terms and conditions of the Connection Offer/Agreement (as varied from time to time) in favour of Customer B in every way as if Customer B were named in the Connection Offer/Agreement (as varied from time to time) ab initio in place of Customer A.

3. Release by SEPD of Customer A

With effect from the date hereof SEPD releases and discharges Customer A from the performance of the obligations of Customer A under the Connection Offer/Agreement (as varied from time to time) arising before, on or after the date hereof and from all claims and demands whatsoever arising out of or in respect of the Connection Offer/Agreement (as varied from time to time) before, on or after the date hereof.

4. Release by Customer A of SEPD

With effect from the date hereof Customer A releases and discharges SEPD from the performance of SEPD's obligation under the Connection Offer/Agreement (as varied from time to time) arising before, on or after the date hereof and from all claims and demands whatsoever arising out of or in respect of the Connection Offer/Agreement (as varied from time to time) before, on or after the date hereof.

5. Miscellaneous

The terms and conditions of this Deed represents the entire agreement between the parties relating to the Novation of the Connection Offer/Agreement (as varied from time to time) and except as specially amended by this Deed all the terms and conditions of the Connection Offer/Agreement remain in full force and effect.

6. Governing Law

This Deed shall be governed by and construed in accordance with the laws of England and Wales and the parties submit to the exclusive jurisdiction of the English and Welsh courts. This Deed must be signed in full by Customer A, Customer B and SEPD. In addition it must be witnessed and countersigned by an appropriate representative on their behalf.
